# Public Act 228 of 2017 (House Bill 5165)\*

## Employer Option

- 54f(1) An employer that is an interested party to a claim for benefits, or the employer's agent, may report to the unemployment agency that the claim is fraudulent because the individual who filed the claim is an impostor.

## Claimant Option

- 54f(2) An affected individual may submit an affidavit to an employer or the unemployment agency. The unemployment agency shall include on its website an affidavit from that meets the requirements of this subsection. An affidavit submitted under this subsection must include all of the following: (a) The name, address, and social security number of the affected individual (b) A statement that the affected individual did not file the claim for benefits with the unemployment agency (c) A statement that the information in the affidavit is complete and accurate (d) The signature of the affected individual.

**\*Effective date of Public Act 228 of 2017 was March 21, 2018**

# Public Act 228 of 2017 (House Bill 5165)\*

## Required Response - Scenario 1

- 54f(3) Upon receiving a report submitted under subsection (1) and an affidavit submitted under subsection (2), the unemployment agency shall do both of the following:
- (a) Make a determination within 2 business days regarding whether the claim is fraudulent and whether the impostor committed identity theft and mail the determination to all interested parties. If the unemployment agency determines that the impostor committed identity theft, the determination must state that the claim is canceled and is null and void. (b) After making a determination under subdivision (a) that the claim is fraudulent, cancel all benefit payments on the claim.

## Required Response - Scenario 2

- Upon receiving only a report submitted under subsection (1) or upon receiving only an affidavit submitted under subsection (2), the unemployment shall do all of the following:
- (a) Notify the impostor by mail that the impostor must, within 10 days after the date of the notice, provide proof of his or her identity by providing the unemployment agency with copies of the acceptable documents as provided in the Form I-9





## Protecting Yourself from Identity Theft

Identity Theft is on the rise in both the private and public sector. Identity theft occurs when someone uses another person's information to take on his or her identity. Identity theft can include misappropriation of wage and employment information, as well as credit card and mail fraud. In the case of unemployment benefits, it could mean using another person's information such as name, Social Security Number and employment information.

Identity theft is often discovered when:

- An individual attempts to file an unemployment claim and one already exists for them.
- An individual receives an IRS statement of benefits collected (Form 1099G) from Unemployment Insurance.
- An individual is notified by their employer that a claim for benefits has been filed when the individual is still employed.

Other signs that an individual may have been affected:

- Request for information from Unemployment Insurance.
- IRS letters about underreporting of benefits you've supposedly received.

Unemployment identity theft not only causes inconvenience and the temporary loss of funds, it could result in wages being garnished, tax refunds being intercepted by the state or the IRS, and much more.

### How Can You Protect Yourself From Becoming a Victim?

- When an individual files a claim for unemployment insurance, they will receive Form UIA 1575C, *Monetary Determination*. If you receive Form UIA 1575C and you have not applied for unemployment benefits, or the name on the form is not yours, you may be a victim of identity theft. If this happens, Contact the Unemployment Insurance Agency immediately online at [michigan.gov/uia](http://michigan.gov/uia) through the *Report Fraud or Report Identity Theft* link or call the UIA Fraud hotline at 1-855-UI-CRIME. Reporting an incorrect Form UIA 1575C may be the best way to stop a fraudulent claim from being paid.
- Guard your Social Security number. Give out the number only when absolutely necessary, and don't carry your Social Security card with you.
- Don't respond to unsolicited requests for personal information (your name, birthdate, social security number, or bank account number) by phone, mail, or online.
- Shred receipts, credit offers, account statements, and expired cards, to prevent "dumpster divers" from getting your personal information.
- Review your credit report at least once a year to be certain that it doesn't include accounts that you have not opened. Check it more frequently if you suspect someone has gained access to your account information.

### What Should I Do If I Am A Victim of Unemployment Identity Theft?

- Contact the Unemployment Insurance Agency immediately to report the fraud. Report fraud online at [michigan.gov/uia](http://michigan.gov/uia) through the *Report Fraud or Report Identity Theft* link or call the UIA Fraud hotline at 1-855-UI-CRIME.
- Complete UIA Form 6349 Statement of Identity Theft and submit the form either in-person at a Problem Resolution Office (PRO), by mail (Unemployment Insurance, PO Box 169, Grand Rapids MI 49501), or by fax (517-636-0427).
- Place a fraud alert and get your credit reports. A fraud alert is free. It will make it harder for someone to open new accounts in your name. To place a fraud alert, you only need to contact one of the three credit bureaus listed below. The company that you contact must tell the other two.

## Protecting Your Business and Employees from Identity Theft

Identity theft is on the rise in both the private and public sector. The growing problem of committing unemployment fraud using stolen IDs not only affects the victims - those who have had their personal information compromised - but it also can have a negative effect on an employer's tax rate.

Identity theft occurs when someone uses another person's information to take on his or her identity. Identity theft can include wage and employment information as well as credit card and mail fraud. In the case of unemployment benefits, it could mean using another person's information such as name, Social Security Number and employment information.

As employers, you can help save millions of dollars in fraudulent payments by identifying suspected fraud. In many cases, you may be the first to have information that unemployment fraud is occurring.

### What You Can Do to Protect Your Employees from UI Benefit Fraud and Lessen the Impact on Your Tax Rate

#### REVIEW Your Employer Notices

- Verify Social Security Numbers at the time of hire, to ensure that your employees' names and Social Security Numbers (SSN's) match the Social Security Administration's records. Visit the SSA at [www.ssa.gov/employer](http://www.ssa.gov/employer) to verify names and SSN's online.
- UI benefits paid to your current employees represent a charge to your account and may impact your tax rate. To protect your account, carefully review all notices received in your MiWAM account or by mail. When an employee files a claim for unemployment, employers will receive Form UIA 1575E, *Monetary Determination*, by mail and online via their MiWAM account. The monetary determination will contain information about the employee, the reason for separation, dates of employment and more. If you notice inaccurate information, or if the employee referenced is still working for you, it is very important that you notify us. Protesting the monetary determination (Form 1575E) timely in these occurrences may be the best way to stop a fraudulent claim from being paid.
- Review and verify all of the information on Form UIA 1136, *Bi-Weekly Statement of Charges/Credits to the Employer's Account*. This bi-weekly statement identifies each person receiving unemployment benefits and the amount being charged to your account.
- Review Form UIA 1770, *Summary of Statement of Benefit Charges and Credits*. This quarterly statement summarizes information previously included on Form UIA 1136.

#### Establish a Strong Data Security Plan

- Protect your employees' personal information.
- Do not use Social Security Numbers or driver's license numbers to identify employees on internal documents, correspondence, etc. Use an alternate employee ID number.
- Limit access to personal information to those employees who need it to perform their job duties.
- Don't mail, e-mail or fax correspondences to an outside source that include personal identifying information. Don't leave any personal information in plain view in the work place.
- Don't share your MiWAM or any other web account credentials where personal information is utilized.

### What to Do if You Suspect Fraud or Identity Theft

- Immediately protest the *Monetary Determination* or the *Bi-Weekly Statement of Charges/Credits to the Employer's Account*. To be timely, the protest must be received by Unemployment Insurance no later than 30 calendar days from the mail date shown on the first page of the form (UIA 1575E or UIA 1136). Please note that although you have 30 days to protest, notifying us within 10 days of the mail date on the monetary determination will help prevent the claim from entering pay status.
  - To send a protest through MiWAM, select the *Account Services* tab, then the *Benefit Services* sub-tab. The link to *Determinations and Decisions* allow you to protest the Monetary Determination. The link to *View Benefit Charges & Credits* allows you to protest the UIA 1136, *Bi-Weekly Statement of Charges/Credits to the Employer's Account*.
  - To submit a written protest, mail or fax as instructed on the letter.
- Please be aware that once payments begin, they will continue until the investigative process is complete.
- Have the victim report the fraudulent activity immediately as well.
