


What is SIDES?



- SIDES allows states and employers to electronically send claim information
 - Six exchanges make up the life cycle of a claim
- Standard formats mean that employers and third-party administrators can expect the same questions from each state
 - Allows for integration and data feeds from their system
- Fast, secure, dynamic

Benefit Charges

- Employer account summary of benefits paid to claimants
- States send these monthly, quarterly, or annually
- Lists all claimants who received benefits during the charge period
- Provides a weekly breakdown for each claimant
